2. Direct assistance method

2. Social administration

3. Social security and insurance

4. Social action

 Social worker participates in the movements of social action at the national (national health program involvement) and international levels(world health days)

5. Social work research

 Social worker inspires surveys and investigations regarding the social ,economic and psychological problems of the victims
