The shaman culture can be found throughout the world, they can be divided into a wide range of flow and science, Quack Quack, Rain Handler Handler of animals, Wizards, Shaman Shaman Shaman Pellet, massages, Baby Shaman (Village Midwife), Shaman Soothsaying, etc. Shaman is a term for them in the language of Indonesia. Abroad they are called with a range of different kinds of name: Clairvoyant (United Kingdom), Macumba, Xango (Brazil), Santeria, Obeah (Jamaica), Voodoo (western part of Africa), which was developed in Haiti in the Caribbean Islands, kejawen (Java).

In an existing village midwife, sometimes you Warlocks litter is still enabled because it is believed that shamans have a dual proficiency increased aid delivery and also master the occult. It is believed that the woman would reply and is undergoing childbirth often plagued creatures unseen.

Most of the people who choose non occupational health personnel in helping labor many people considered that shaman have advantages compared to medical personnel, may examples: a shaman ready requested help at anytime needed, within easy reach, from the aspect of labor cost is cheaper, can be replaced with the payment of the goods as well as the existence of intimate relationships and are family hood with the helped mothers. Besides baby shaman is willing to help the implementation of traditional ceremonies

relating to pregnancy and childbirth is still rooted in the community.

Maternal and child health is one measure that can affect the human development index (HDI). In addition, the quantity and quality of professional midwives will be the focus of attention in the development process of explaining . Based on HDI jabar 2007, maternal mortality ranges from 320/100,000 live births. While infant mortality reached 43.4 live births/100. In addition, 38.77% birth helper is a non medical. As a result of the high risk of maternal and infant mortality, of 400,000 birth was still handled by non-powered health. Linked to it a midwife as the competent authorities have become very significant for maternal and child health kelangsuran what's in the process of childbirth. Midwives must also establish partnerships with academics and other professional organizations in order to make maternal and child health conditions of post childbirth increases.

Social Behavior

Social behavior is an activity or action from the man himself, who has a very wide stretch include: walking, talking, crying, laughing, working, lectures, writing, reading, and so on. From this description it can be concluded that the intended behavior is all activity or human activities, either directly observed, and which cannot be observed by outside parties. (Notoatmodjo, 2003).

According to Skinner, (Notoatmodjo In 2003), formulating that behavior is a response or reaction someone against the stimulus or stimulation from the outside. Because of this behavior occurs through the process of the existence of a stimulus towards organisms, the organisms and then

responding, then the theory is called Skinner's theory of "S-O-R" or Stimulus – Response – Organisms. Judging from the form of the response to this stimulus, then the behavior can be distinguished into two (Notoatmodjo, 2003):

1. Conduct closed (convert behavior)

Enclosed is the response behavior of a person against the stimulus in the form of veiled or covered (convert). Response or reaction to this stimulus is still limited in attention, perception, awareness, knowledge, and attitudes that occur in people who receive the stimulus, and yet clearly observable by others.

2. Open Behavior (overt behavior)

The response of a person against the stimulus in the form of concrete action or open. The response to the stimulus is already evident in the form of acts or practices, which can easily be observed or seen by others.

Social behavior is an atmosphere of mutual dependence which is a must to guarantee the existence of mankind (Rusli Ibrahim, 2001). As evidence that humans have the necessities of life as a personal self unable to do it myself but need help from others. There is a bond of interdependence between one person to another. It means that the survival of humans is taking place in an atmosphere of mutual support in togetherness. For that man being sued are able to work together, respect each other, do not interfere with the rights of others, tolerance in life of society.

Krech and Crutchfield, according to Ballachey (1982) in Rusli Ibrahim (2001), a person's social behavior that appears in the pattern of responses between people manifested with mutual interpersonal relationships. Social behavior is also identical with the person's reactions towards others (Baron & Byrne, 1991 in Rusli Ibrahim, 2001). That behavior is demonstrated with feelings, actions, beliefs, memories, attitude or respect for others. A person's social behavior is relative to the nature of responding to others with different ways. For example, in doing the same work, there are people who do it diligently, patient and always concerned with his personal interests above the common good. While on the other hand,

there are those who are lazy, do not wait, and just want to find a good thing on its own.

Indeed, that is the basis of the above description is that on the fact that humans are social animals (W.A. Gerungan, 1978:28). Since the human being is born in need association with others, to fulfill biological needs. In the development towards maturity, social interaction among human beings realize their lives individually. This is because if there is no reciprocity of social interactions, then the human cannot realize as individual intact figure as a result of social interaction. On the one hand, there are still several villages that have health problems that the mortality rate for pregnant women, babies and baby are still relatively high, on other aspects of the program placement of Midwives in many corners of the remote areas have the goal to lower the mortality rate of pregnant women, babies and toddlers have yet to show optimal results, it is still the large amount of labor that occurs in some areas performed by shamans baby This means that the Shaman Baby still holds an important role in helping labor

The selection of aid delivery:

1. Level of education

Education is highly influential in determining the decision, meaning that the higher the education of someone sure is getting ripe in making a decision, given that education can affect a person's intellectual style in deciding a matter including the decisive help of labor. The result of the birthing mother's education is lacking, this led to his intellectual power is still limited, so that the effect on aspects of the behavior of the circumstances surrounding

2. Knowledge

Between education and knowledge is a thing that is necessary to change the mindset, so with the extensive insight will have an impact on the State of a day today, in order to change the mindset and behavior of groups and communities. This knowledge is related to the environment where the community settled. The State of the environment around a little to much will affect knowledge. In this case the knowledge about pregnancy and childbirth. In addition, communication with the media exposure will affect the levels of knowledge.

3. The Status

Besides the factor of education and knowledge of one's status was instrumental in creating change, high labor through the shaman tradition factors besides litter is usually influenced by socio-economic factors. However, for economic reasons can be anticipated by the Labor Fund assistance program for poor families.

The community with the status of poor citizens have cards Jamkesmas so they only pay just a little when the midwife helps the process to give birth because health costs they have been subsidized by the Government through the possession of Card Jamkesmas. Similarly, if the community has a Poor population of Affidavits from the local subdistrict then they will get relief from the fees for health care facility (Hospital, Clinic or Clinics Attendants). Thus the existence of guarantees for financing of health means a lot by looking at the scope of aid delivery by health workers on family status of the poor are greater than the selection of health care personnel.

4. Custom

Habit is a condition that occurs repeatedly reset done consciously. The person's behavior is influenced by habit a day – a day in which he lived and grew up. Habit is a fundamental thing that affects the person's behavior, including health behaviors in this pregnancy and childbirth. However, factors of education and knowledge have become in changing habits. 5. Affordable Service

In addition to the four factors that one of the other factors influencing the selection of aid delivery by the public is the affordability of health care facility. The issue of affordability of health care

means not so mean to be determinants of electoral aid delivered by the birthing mother.

As a form of professional service, then a public officer can directly provide service to the community, then the community can give judgment or views of service given by a midwife. Although in general the community looks at that services provided by a midwife in the community already is good enough, but with the condition of the midwives are diverse both in terms of the ability of handling patients, personality, sense of take decision and desire to serve

Some of the views and assessments of the community towards the services provided by midwives.

First, in general the community looked at the services provided by midwives to society is already good enough. Usually they are willing to be called if anyone needs help. An informant says: There are many complaints expressed concerns with regard to the readiness of midwives provide succor is when a midwife asked provide succor in the evening. In between there is a reluctant midwife came in at a moment's notice, in terms of the process of birth could not be postponed. In addition, there is the view that midwives in providing the services most also tend not to be proactive, in that sense tend to wait to be called either at the time of the examination the pregnancy, childbirth or post help gives births, a informant says:

"Generally the midwives didn't want to come to the House the population with various plinth an unless forced to. Different things with a shaman, if the litter is shaman want to come home residents ".

Second, according to some community midwives are seen less patient in keep the mother will give birth. Usually a midwife will indeed go home again to her home after seeing his birth is estimated to be still for long (several hours). So sometimes when the midwife came for the second time the baby is already born, under the help of

the shaman. When compared, the shaman indeed generally tends to be more patient and painstaking. Usually a shaman will keep steadily ever since he was called up to the process of birth.

Third, when viewed from the ability of midwife in pregnancy checks and helping labor, generally a midwife is seen is quite capable of doing its job. Compared to traditional birth attendants, in general the public perceives that midwives are smarter and better able to deal with pregnancy and childbirth. The reasons expressed, among others, that to be a midwife had to school long enough, and owned equipment is also more complete.

Fourth, generally a midwife is a newcomer, in the sense that it is not a native population. With this kind of condition would give influence to the pattern of social relationships with residents of the village midwife where he was assigned. For example, there are midwives who are less able to communicate well with the locals, particularly for midwives. In addition, there is a midwife who does not live in the village of misplaced duty. As a result the public has trouble when at times need help.

Fifth, according to the community's assessment of the cost of the examination and aid delivery, it is generally looked upon quite expensive. Although not explicitly admitting objected to the tariff imposed when asked for the help of a midwife, but generally they compare with low cost labor through the shaman. The difference in the magnitude of the fee was to be one of the important considerations for choosing whether to help midwife or herbalists.

The large number of cases, the situation where due to lack of many who initially into midwives to get help but as it costs nothing and so he resigned to go shaman.
